Adil Amor graduated from CentraleSupelec in 2010 with a Master of Advanced Studies in Signal Processing (Paris Sud 11) and a Master of Advanced Studies in Probability and Finance (Nicole El Karoui) from the Ecole Polytechnique. After his first experiences at Amundi and Crédit Suisse, Adil joined Schelcher Prince Gestion in 2011; in 2015, he joined BMCE Capital Gestion in Casablanca to create and take responsibility for the Multi Assets department, before joining the OCP group to set up the group's strategic and financial planning department. In 2020, he returned to Schelcher Prince Gestion as Chief Risk Officer then Deputy CIO.
